## **§ 2 Scope of Application**

Access to and use of this website and the products and services available through it are subject to the following terms and conditions. By using the services, the customer is agreeing to all of these terms of business in its current version. Any waiver of any provision of the terms will be effective only if in writing and signed by PRETTIE LANES.

Contracts via [www.prettielanes.com](http://www.prettielanes.com) are exclusively made with private end-consumers (henceforth “customers”). The commercial use or resale of the offered products is not allowed without express permission by PRETTIE LANES.

## **§ 3 Contract**

By placing an order (‘Buy’ button) the customer is offering to purchase a product on and subject to the following terms and conditions. PRETTIE LANES reserves the right to refuse any request made by the customer. Your order is accepted by sending you a confirmation email, respectively by sending the ordered products to the customer.

## **§ 4 Availability**

Since PRETTIE LANES produces only small quantities or unique pieces it may occur in exceptional cases that an offered product is not available after your purchase, even though it was marked as “available”. In such a case, PRETTIE LANES would immediately contact the customer and if necessary refund payments.

## **§ 5 Prices**

All prices are to be understood as end-prices in Swiss Francs (CHF), excluding charges for packing and postage that will be displayed separately during the order process.

PRETTIE LANES is not liable to value added tax (VAT).

## **§ 6 Payment & Reservation of proprietary rights**

The ordered products remain the property of PRETTIE LANES till the full payment is received from the customer. The customer can choose between the following payment methods:

### **Prepayment**

The invoice total shall be transferred to the account of PRETTIE LANES as stated in §1. Having received the full payment, the ordered products will be produced and dispatched within the timespan stated on each product - page.

## **PayPal**

For fast and secure payments, the customer can use the online payment service PayPal as well. The customer decides whether to pay via direct debit, credit card or with an existing credit on his PayPal account. The payment using PayPal does not cause any additional charges. ## **Vouchers**

Vouchers issued by PRETTIE LANES are of course an accepted payment method. For this purpose, the voucher can be redeemed by entering the voucher number during the order process. Afterwards, the amount due will be automatically reduced by the voucher credit. Please note that the voucher cannot be disbursed.

## **§ 7 Shipment & Delivery Charges**

### **National Shipping**

National deliveries will be shipped insured and with a tracking number within 24hours (on workdays) after they have been dispatched. The ordered products will be produced and dispatched within the timespan stated on each product - page, after the full payment due has been received by PRETTIE LANES (see banking information §1).

Flatrate: 8.00 CHF

In case, the products are not delivered within 7 days after dispatch, we advise the customer to immediately contact PRETTIE LANES ([info@prettielanes.com](mailto:info@prettielanes.com)). Using the provided tracking number it will be checked, where the parcel is located.

### **International Shipping**

International deliveries will be shipped for a flatrate of 14.00CHF to EU countries and 28.00CHF to the rest of the world. The order will be shipped with a tracking number in. The ordered products will be produced and dispatched within the timespan stated on each product - page, after the full payment due has been received by PRETTIE LANES (see banking information §1). Please note, that the delivery times vary depending on the destination.

It is pointed out, that the customer has to bear possible collected import taxes and duties.

PRETTIE LANES ships worldwide.

## **Custom-Made/ Made-to-Measure Goods**

It is pointed out, that goods individually produced or customized for customers (made-to-measures) have longer delivery times.

### **§ 8 Return Policy**

**In case of exercising the right of withdrawal the customer has to bear the costs of returning the goods in any case.**

**It is pointed out, that items must be unused, unwashed, with all original tags attached and in the same condition that it was received, to be returned. PRETTIE LANES reserves the right to refuse a return that does not meet the standards stated.**

### **Right of Withdrawal**

Customers are entitled by applicability of the regulations for distance contracts to a right of revoking the contract on condition within 7 days of the following instructions (cf. Art. 40a ff. OR).

Any order with PRETTIE LANES is binding. For that reason, is was paid attention to provide the customer with detailed pictures and description of the offered goods as well as an appropriate size chart available at the website, in order to avoid returns where possible.

In case of damaged goods or delivered goods that do not match the customers' order, PRETTIE LANES will refund without further ado. The order can be revoked within a revocation period of 7 days without further specification of reasons in written form (e.g. letter or e-mail: [info@prettielanes.com](mailto:info@prettielanes.com)) or by returning the goods. The revocation period does not start before the delivery and the reception of this instruction. Punctual dispatch suffices to comply with the time limit. The revocation must be declared to:

In case of international returns the customer is ask to clearly mark the parcel with 'No commercial value- returned goods'. Its the customers obligation to return all goods insured and trackable.

## **Effective Revocation**

In case of an effective revocation, any performance received by one party is to be returned to the respective other, as are benefits derived from such performance (e.g. interest). If the customer cannot return the goods received in whole or in part or if the customer can only return the received goods in a deteriorated state, the customer has to pay compensation for value insofar. There is no duty to pay compensation for value, if the sole cause of deterioration of the goods received was the inspection of the respective goods, as would have been possible in a retail shop. For the rest, the customer can avoid paying compensation for value in respect of deterioration in the goods as a result of its proper use. The customer has to bear the costs of return, in case the delivered goods match the goods ordered. Obligations to refund payments have to be fulfilled within 30 days. This period does not start previous to PRETTIE LANES receiving the returned goods.

When returning goods, the customer should always consider to use a trackable shipping service, including a shipping insurance. PRETTIE LANES cannot guarantee to receive returned items.

### **Non – returnable items: Made-to-Measures/ Customized Items, Vintage/Second Hand Goods, Jewelry**

These Rights of withdrawal does not apply to products manufactured according to the customers' specification (made-to-measures, customized). A return in those cases is not accepted. In case, the customer requests a cancellation of the custom order PREVIOUS to the production of the order, the payment will be refunded within 30 days subtracting an expense allowance of 30% that will remain with PRETTIE LANES (i.e. for already bought materials, drawn sewing patterns).

Vintage/Second Hand items are excluded from a right of withdrawal as well. Jewelry is for hygienic reasons excluded from a right of withdrawal.

## **§ 9 Liability**

Only in case the customer claims damages based on deliberate action or gross negligence, PRETTIE LANES is liable in accordance with standards and statutory regulations and laws.

## **§ 10 Transport Damages**

In case, a customer realizes transport damages to the goods ordered, at the point of delivery, the customer is asked to demand a written confirmation of this damage from the corresponding employee of the shipping company and to inform PRETTIE LANES. If possible, the customer may take pictures of the damages.

However, the omission to demand this written confirmation has no influence on the customers' right of withdrawal. In fact, such a confirmation would assist PRETTIE LANES in bringing complaints to notice towards the shipping company.

## **§ 11 Privacy Policy**

PRETTIE LANES uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"). Google Analytics uses "cookies", which are text files saved on the customer's computer, to help the website analyze how he uses the site. The information generated by the cookie about the customer's use of the website will be transmitted to and stored by Google on servers in the United States.

If this website anonymizes IP addresses, the customer's IP address will be truncated by Google within a EU member state or other EEA state before being transmitted to the US. Only in exceptional situations the full IP address will be transmitted to Google servers in the United States and truncated there.
